The work that library employees do every day in our library systems is absolutely essential to our communities here in Maryland. From providing necessary services, promoting literacy, and fostering safety and community, library staff are on the frontlines when it comes to ensuring that Maryland residents can grow and learn. We are proud to organize with Wicomico public library staff and move toward sorely needed improvements in wages, benefits, and working conditions.

Lisa Bryant O'Day, a Unit Supervisor of Court Operations with the District Court of Maryland, was issued a written reprimand by management, who falsely claimed she had been incompetent or ineffective in her assigned duties. However, Ms. O'Day knew the truth: unclear directives were the culprit, not her behavior. The MCEA team and Ms. O'Day worked together to ensure her stellar work record of 37 years was not affected by this unfair oversight, and the hearing officer removed the discipline from her file as a result.
